#### CIRCULAR

It is Proposed to fill – Up one post of Jr. Hindi Translator and one post of Upper Division Clerk in Regional Office of the Ministry of Environment Forest, & Climate Change, Bangalore, on deputation basis from among the officials of Central / State Governments Department or Union territories or Recognised Research Institutions or Public Sector Undertakings or Semi-Government or statutory or autonomous organisations. . Qualifications required for the posts can be seen at Annexure – I and II respectively.

The terms and condition of the conditions of candidates selected for appointment on deputation basis will be governed as laid down in the Government of India, Deptt. Of personnel & Training OM. No. 6-8/2009- Estt Dated 17.06.2010 &MoEF&CC File No.6-21/2010-ROHQ (Vo.I.I) dated 19.08.2016 as amended form time to time.

The period of deputation will be initially for three years and likely to be extended up to 5 Years.
